




## NOTICE OF TOLL(S) DUE

August 28, 2005



The Maryland Transportation Authority now uses a system of electronic toll collection, known as E-ZPass, at many of its facilities.

The vehicle identified below was recorded by video monitoring associated with *E-ZPass* as having passed through a Maryland Transportation Authority toll plaza without paying the required toll(s) in accordance with Maryland law. If you pay the toll(s) due by the payment due date below, you will not be subject to additional fees and fines for the violations listed.

If you are an *E-ZPass* Maryland customer and have question regarding this notice, please call the *E-ZPass* Maryland Service Center to check the status of your account. You must still pay the toll(s) due by the payment date to avoid additional fees. If you are not an *E-ZPass* Maryland customer but regularly use the Maryland toll facilities, you may wish to open an *E-ZPass* Maryland account. Call the *E-ZPass* Maryland Service Center at 1-888-321-6824 for more information.

Failure to pay the toll(s) by the payment date constitute toll evasion and will result in a \$15 administrative fee for each violation listed along with any subsequent violation incurred after receipt of this notice. Continued failure to respond or continued toll violations will result in progressive penalties, including a \$50 civil penalty fine for each toll violation and the non-renewal or suspension of your motor vehicle registration.



Notice: You are liable for the tolls and fees described on the attached Notice of Liability. Under Maryland law, Transportation Article Section 21-1414, it is presumed that the registered owner of the vehicle committed the violation. On Motor Vehicle Administration records, you are listed as the registered owner on the date of the violation.

However, if you did not own the vehicle on the date of the violation, or if it was leased, rented or being operated by someone else, you may not be liable. To avoid liability and further fines, and penalties, you must provide the following information to the Maryland Transportation Authority:

The result of the investigation will be mailed to you first-class mail. If, upon completion of the Administrative Review, it is found that you remain liable, you will have fifteen (15) days from the date the results of the investigation were mailed to remit the amount due. Failure to pay the amounts due will result in the imposition of additional fines and fees and/or the suspension or revocation of your motor vehicle registration.
